

## GRAND ASSEMBLY OF TEXAS

### GRAND APPOINTMENT RECOMMENDATIONS: 2021-2022

#### Requirements:

The **Recommendation for Grand Appointment 2021-2022** form in the *Texas Rainbow News* and **web site** must be completed in order to be considered. Unfortunately, incomplete recommendations will not be considered.

To be considered for a Grand Appointment, a Rainbow Girl must be a Past or Present Worthy Advisor at the time this recommendation is made, and age 19 or younger at the time of the Installation Ceremonies at Grand Assembly 2021.

The recommended girl must attend Grand Assembly Session in 2021 and 2022.

The girl who is recommended must be present at the time her name is called at Grand Assembly Session 2021 or the appointment will not be honored. **ATTENTION:** The Mother Advisor **ONLY** will be notified of a Grand **Floor Officer** Appointment. All other appointments are announced at Grand Assembly Session.

All Grand Appointments **must** subscribe to the *Texas Rainbow News* with her subscription expiring no earlier than Jan/Feb/Mar 2022. Grand Representatives are required to send a gift subscription to their counterparts in the states they represent. This compliance must be reported to the Director of Grand Representatives.

All Grand Appointments will list Mrs. Weaver and other members of the Grand Executive Committee as a “friend” on their Social Media accounts, knowing that a member of the Grand Executive Committee will monitor these accounts for appropriate personal information and presentation.

The recommended girl *should* be living in the State of Texas during the 2021-2022 year. If not, note where will she be living and how will she make her required visits to represent Texas Grand Assembly. **Attach** explanation to Recommendation Form.

All other requirements for Grand Appointments as specified by the Supreme Inspector must be met, including, but not limited to, following the Texas Dress Code, making all required visits and also reporting her monthly activities on a timely basis. See Rules and Guidelines for All Grand Appointments that will be presented at the installation practice at Grand Assembly.

All Grand Appointments will be required to sign a contract of performance and commitment as a Grand Officer.

A special Grand Officer formal will be **required** for all Grand Floor Officer appointments, all Grand Flag Bearers **and** Miss Service to Texas Rainbow. All other Grand Appointments **may** purchase the Grand Officer formal. Order forms will be presented at the installation practice at Grand Assembly, immediately after the Sunday morning session.

Grand Appointments installed at Grand Assembly 2021 but not attending Grand Assembly 2022, will not be considered a Past Grand Appointment and will not be recognized in historical records.

On a separate sheet of paper, list additional information and any other qualifications of the girl. **Attach** it to the completed **Recommendation for Grand Appointment 2021-2022** form. Include any information that you feel would be helpful in the consideration of the recommendation. Your additional information and letters of recommendation are important in the selection process. Each **attached** page should include the assembly name and name of the girl at the top of the page.

A photo is required. This may be an informal snapshot or part of a group photo.

A meeting of all newly appointed Grand Appointments, and at least one parent/guardian/ or the Mother Advisor, will be held immediately after the Sunday morning session. This is required.

**Please note that all recommendations must be received by March 1, 2021**
