

GRAND ASSEMBLY OF TEXAS

2025–2026 GRAND APPOINTMENT RECOMMENDATION

Requirements:

The **2025-2026 Recommendation for Grand Appointment** form published in the *Texas Rainbow News* or on the **website** must be neatly completed for each member to be considered. Incomplete recommendations will not be considered.

To be considered for a Grand Appointment, a Member must be a Past Worthy Advisor at the time of the Installation at the 2025 Grand Assembly Session, as well as nineteen (19) years of age or younger.

The recommended Member must attend the entire Grand Assembly Session in both 2025 and 2026.

The Member recommended must be present at the time her name is called at the 2025 Grand Assembly Session, or she will forfeit her appointment. **ATTENTION: ONLY** the Mother Advisor will be notified of a Grand **Floor Officer** Appointment. All other appointments are announced at the 2025 Grand Assembly Session.

All Grand Appointments **must** subscribe to the *Texas Rainbow News* with her subscription expiring no earlier than Jan/Feb/Mar 2026. All Grand Representatives are required to send a gift subscription to their counterparts in any state they represent. This compliance must be reported to the Director of Grand Representatives and will be verified through Ms. Suzette Faith, who processes TRN subscriptions.

All Grand Appointments will list Mrs. Seymour and other members of the Grand Executive Committee as a “friend” on all Social Media accounts, knowing that a member of the Grand Executive Committee will monitor these accounts for appropriate personal information and presentation.

The member recommended **should** be living in the State of Texas during the 2025-2026 Grand Assembly year. If not, indicate where she will be living and how she will make the Rainbow meetings required to represent Texas Grand Assembly. Attach this explanation to Recommendation Form.

All other requirements for Grand Appointments as specified by the Supreme Deputy must be met, including, but not limited to, following the Texas Dress Code, making all required visits in addition to reporting on her monthly activities on a timely basis. Refer to the Rules and Guidelines for All Grand Appointments that will be presented at the installation practice at Grand Assembly.

All Grand Appointments are required to sign a contract of performance and commitment. Failure to meet requirements will result in their being removed from office. All Grand Appointments serve at the discretion of the Supreme Deputy.

A special Grand Officer formal will be **required** for all Grand Floor Officer appointments and the Grand Flag Bearers. All other Grand Appointments **are welcome to purchase** the Grand Officer formal. Formal order forms will be available on the txiorg website a few days following the conclusion of the 2025 Grand Assembly session.

Grand Appointments installed at Grand Assembly 2025, but not attending Grand Assembly 2026, will not be considered a Past Grand Appointment. They will not be recognized in historical records and may not introduce themselves as such.

Create a separate document with any additional information and qualifications of the member. **Attach** it to the completed **2025-2026 Recommendation for Grand Appointment** form. Include any information that you feel would be helpful in the consideration of the recommendation. Your additional information and letters of recommendation are important in the selection process. Each **attached** page should include the name of the member and her Assembly at the top of each page.

A photo is required. This may be a formal or informal individual photo or a group photo.

The Supreme Deputy will meet with all newly appointed Grand Appointments, with at least one parent/guardian or Mother Advisor present, immediately following the Sunday morning session. This meeting is required.

Note that all member recommendation packets must be received by March 1, 2025. No exceptions.
