

## Grand Assembly of Texas Grand Line Officer Procedures and Policies 2025-2026

### Grand Assembly Line Officers

The office of Grand Worthy Associate Advisor will be an advancing office to Grand Worthy Advisor under the following conditions:

- ❖ The GWAA completes all required visits and reports during her year as GWAA.
- ❖ The GWAA follows all rules and guidelines for Grand Officers during her year as GWAA.
- ❖ The GWAA works closely with the Supreme Deputy as required to develop plans for her year as GWA.
- ❖ The GWAA does not reach the age of twenty (20) prior to the date of her intended installation as GWA.

The office of Grand Worthy Associate Advisor will be **selected** by the Grand Executive Committee at the conclusion of the interviews.

The offices of Grand Charity, Grand Hope and Grand Faith will serve for one-year terms and will not be automatically advancing offices. (*Grand Faith will not automatically advance to Grand Hope, and Grand Hope will not automatically advance to Grand Charity.*)

### Requirements

To be eligible for any line office, members must complete an Eligibility and Availability Form (available on the txiorg **website**).

- ❖ This form must be **received** by the Supreme Deputy by the published deadline of **March 1, 2025**. *Do not mail or send forms requiring her signature at the time of delivery.* A timely postmark is not considered receipt.

To be eligible for the office of Grand Worthy Associate Advisor, a girl must be at least seventeen (17) years of age, have been a Grand Officer, and no older than eighteen (18) years of age at the time of Installation at the 2025 Grand Assembly Session.

To be eligible for the offices of Grand Charity, Grand Hope and Grand Faith, a girl must be at least sixteen (16) years of age, be a Past Worthy Advisor (*at the time of Grand Assembly elections*) or been a Grand Officer (*current or past; not limited to Floor Officers*), and no older than age nineteen (19) at the time of Installation at the 2025 Grand Assembly Session.

- ❖ All other requirements listed on the Eligibility and Availability form (available on the txiorg **website**) must also be attached.
- ❖ Do not omit the required attachments.

### Eligibility Determination

**All** applicants for Grand Worthy Associate Advisor are **required** to interview with the Grand Executive Committee. These interviews are scheduled for **April 5, 2025**. The selection of Grand Worthy Associate Advisor will be determined as a result of these interviews along with the review of the Grand Line Officer Eligibility and Availability forms submitted.

An interview is also **required** for the offices of Grand Charity, Grand Hope and Grand Faith, and are scheduled for **April 5, 2025**.

Her historical reporting record for current and all prior Grand Offices and her adherence to all rules and guidelines for Grand Officers will also be evaluated as a part of her eligibility for a line office.

### Electioneering or campaigning for elected or selected office is absolutely not permitted. No exceptions.

- ❖ Any girl who is engaged in electioneering or campaigning will have her name removed from eligibility.
- ❖ Any girl whose name is being promoted by others will also be removed from eligibility.

Include any additional thoughts or ideas you feel are important for the Grand Executive Committee to be aware of when considering your application.
3. Remember to sign your letter.
4. Return this form, and all **attachments**, including your photo, to the Supreme Deputy, to be received by **March 1, 2025**. In fairness to all, a timely postmark is not considered to be received by the deadline.

**Eligibility Requirements:** To be eligible, I understand that:

1. I must be a Past Worthy Advisor (*at the time of Grand Assembly elections*), a Past Grand Officer or a Present Grand Officer.
2. I must be at least 16 years of age and have been a Grand Officer, and no older than age 19 at the time of Installation at Grand Assembly 2025 for the offices of Grand Charity, Grand Hope and Grand Faith and to be considered for Grand Worthy Associate Advisor, I must be at least 17 years of age and no older than 18 years of age at the time of Installation at the 2025 Grand Assembly Session (refer to Grand Line Officer Procedures and Policies).
3. If I am currently a Grand Officer, I understand that all my reports must have been made for the Grand Assembly year on a timely basis, and all other guidelines for Grand Officers/Grand Appointments must have been fulfilled. If I am a Past Grand Officer, I understand that the record of my previous Grand Appointment(s) reports will be evaluated as well as my compliance with all rules and guidelines for Grand Officers.
4. I understand that as an applicant for a Grand Line Office, I will be **required** to interview with the Grand Executive Committee. I also understand that the Grand Executive Committee determines placement on the Grand Line Office ballot, and that my name may not be included on this ballot at the conclusion of the interview process. (These interviews are **tentatively** scheduled for **April 5, 2025.**)
5. If I am selected as a Grand Floor Officer (non-elective), and I have previously submitted an Eligibility and Availability Form for Grand Office, I understand that I must choose whether to accept the Grand Floor Appointment OR to continue to be available for a *possible* elected or selected Grand Line Office position.
6. I must be present and participate in all meetings and activities of the 2025 and 2026 Grand Assembly Sessions, including, of course, the Installation Ceremonies at the 2025 and 2026 Grand Assembly Sessions.
7. I will be living in the state of Texas during the 2025-2026 Grand Assembly year.
8. I understand that attendance at the Mid-Year Meeting is required.
9. I will make every effort to attend Rainbow Universities, the Grand Floor Officers' Retreat, Girls' Leadership Conference and Official Visits and Receptions/Honor activities during the 2025-2026 Grand Assembly year.
10. I agree to explicitly follow **all** rules and guidelines for Grand Officers/Grand Appointments, including, but not limited to, attending at least three meetings per month during the 2025-2026 Grand Assembly year, making all required monthly reports on a timely basis and explicitly following the Texas Dress Code.
11. I understand that I will be required to sign a Contract that will confirm my commitment to serving Rainbow.
12. I will list Mrs. Seymour and members of the Grand Executive Committee on my Social Media accounts, knowing that a member of the Grand Executive Committee will monitor my accounts for appropriate personal content and presentation.
13. My name, address, and email address will appear in the **Texas Rainbow News**, along with individual and group photos.
14. I understand and acknowledge that I serve the Grand Assembly of Texas at the discretion of the Supreme Deputy, and I may be removed from office at any time.

I agree with all the above requirements and understand that I may be disqualified or removed from office if these requirements are not met. I also agree that I will serve the Grand Assembly of Texas with honor and dignity; that my conduct will honor the high standards and values of Rainbow 24/7 and that I will recognize the authority of the Supreme Assembly, the Supreme Deputy or others placed in authority to direct the affairs of Texas Rainbow.
